
Meeting called to order at 7:33 pm

- I. Summary:

Russ deposited \$2,025 in donations from the Lions Clubs to support our JO program. The chart below shows individual and club membership, as well as sanction revenues for 2021 and the last five years. June was our best month for membership revenue in two years. However, our main revenue sources are still down. Specifically, compared to the last five-year average, individual membership revenues are down 43%, club membership revenue is down 45%, sanctions revenue is down 57%, and total revenue is down 51%.

By-Laws revision from 2020 Annual Meeting

Unfinished business – Motion to remove Bylaw Section 6c (Electronic Voting) from table from Russ, 2nd from Jennifer, motion approved. Motion to put language in by-laws to allow online voting and virtual meetings, 22 for 2 opposed, 1 abstention, motion approved.

Text for Updated By-Laws - Motion by Don Lawrence, 2nd by Fred Covelli, Vote - Passed

All in-person meetings of USATF Niagara will also be available Virtually. The Board of Directors may call a Virtual Meeting in place of an Annual Meeting or Special Meeting using an on-line teleconference service in the event of special circumstances. Notice of this Virtual Meeting shall follow the same timeline as an in-person Annual or Special Meeting.

A reputable electronic election and voting platform shall be utilized. All applicable nomination processes and voting criteria shall apply. The on-line voting shall be open to all members who would have been eligible to vote at an in-person meeting held on the date of the Virtual Meeting; the voting shall be open for a minimum of 15 days after the members are provided with email notice and instructions,

The voting process shall be overseen by an election committee consisting of the board members not up for election.
