

Board of Directors Meeting Monday February 19, 2024

The February meeting of the Niagara Association Board of Directors was called to order by President Don Lawrence at 8:05 pm EST. The following Board members were present at the start of the meeting: Mike Nier, Eric Boyce, Don Lawrence, Rozanne Redlinski, Kathy McLymond, Perry Jenkins, Brett Shelton, and Kraig Connor. Danielle Anderson was attending as a guest and Fred Covelli entered the meeting at a later time. Absent from the meeting were Michelle Bogdan, Jim Glinsky, Matt Merrill, Jacky Mendes and Dave Reinhardt.

- 1. Approval of the Minutes from the December meeting.
 - a. Minutes were approved with one change involving the date of the January track meet.

2. President's report:

Don congratulated the Niagara's 3 marathoners who competed in the USA Olympic Trials. These three athletes were Joey Whelan, Henry Williams and Dominic Hockenbury . Sammy Watkins (800m) and Kyra Pellegrino (3000m Race Walk) competed at the USATF Indoor Championships in Albuquerque and finished 4th and 8th, respectively. The Youth Nationals that were to be held in Kentucky was cancelled because of low registration numbers.

The USATF Niagara Clinic Weekend will be held on March 23/24 and possibly the first weekend in April. Don is lining up presents for these clinics.

Danielle Anderson has been appointed to the USATF Women's Commission.

Chair Reports:

- 3. VP Operations: Fred Covelli was not present at this time.
- 4. VP Administration: Michelle Bogdan was not present. Don Lawrence has contacted her about her continued absences and has asked her to step down from the VP of Administration position, but keep the position of the SafeSport Chair.
- 5. Treasurer's report: Jacky Mendes was not in attendance but sent in the report seen at the bottom of these minutes. She and Don are working on the budget for 2024.

7. Youth:

- a. Brett and Danielle talked about the reasons for the Youth Meet cancellation. They also stated that Ocean Breeze is offering a Region1 Youth Invite at Ocean Breeze on March 16-17. There are over 1000 athletes registered.
- b. Free Covelli joined the meeting and reported that the New Jersey Association will be hosting a Region 1 Championships at possibly Rutgers July 12-14.

8. LDR:

- a. Eric Boyce's report is attached at the bottom.
- b. Eric discussed the excitement surrounding the marathoners and shared part of the 2024 Running Series.
- c. Perry Jenkins asked if any of the races could become a Canada/US competition. Mike thought it would be possible. They are going to look into this.
- 9. High Performance: Matt Merrill was not in attendance.
- 10. Officials: Kathy McLymond had not report but answered questions about some new officials and the process of becoming certified. The Olympiad exam will be in October.
- 11. Sanctions: Dave Reinhardt was absent.

Old Business: The three athletes that competed in the marathon trials will be reimbursed \$300.00 apiece.

New Business:


