LDR report:

I'm reaching out to Andy Martin to put something on the website for ppl to contact/submit/report results from our members. We as the board are volunteers and can't keep track of everyone so this will help put some of the ownership onto our members to help us out. This stems from Andy posting something this year and because he didn't post something from the following year, I got blamed and attack for it by an individual.

May 4th was our 10mile championships, mountain goat in Syracuse

2024: 78 members

2025: 72 members

It's a tad lower from last year. However, there was less than 10 members from the Syracuse area this year and last year there was closer to 25-30. Syracuse is a tricky part of the association. There is a great running scene and a lot of club involvement. However it appears there usaff involvement in the last few years have dwindled.

I'm adopting a new association rule for our LDR championships, there was some controversy at mountain goat over a nonexistent uniform rule. National doesn't address or have any rule in place stating it's mandatory for open athletes with team scoring to where the same uniforms. I did find a few associations do address this rule. I plan on modeling and tightening this up before our next championship.

I'm considering retooling the Grand Prix and runner of the year series. I am consider creating a separate MUT series which I have mix thoughts about. It might promote more membership in the trail scene to non members currently but I think it might weaken the overall Grand Prix series competitiveness. This idea comes from we have a lot of Fairweather road runners that complain about MUT even though they aren't being forced to run them. Iol.

I also recently had some conversation with Muddysneakers race director for some usatf involvement. This race is probably our associations most historic trail race. The race recognizes the crowd that's been running the race for the last 20 years is getting older and how can the race regenerate and appeal to a younger crowd for future sustainability.

I was out at the lilac 10km yesterday. This is evidence that what we do in LDR matters. In 2023 was the last time they hosted an association championship. In 2023 51st place broke 40 minutes in the 10km. Without the race hosting our championship, 2025 12th place broke 40 minutes. The race does seem to be thriving from a numbers stand point of participants but this demonstrates the value we bring with our members from the competitive side.


